## ISTANBUL KÜLTÜR UNIVERSITY CONSENT FORM FOR PROCESSING AND TRANSFERRING PERSONAL DATA ABROAD

As Istanbul Kültür University ("Data Controller," "Istanbul Kültür University," "We"), within the scope of Law No. 6698 on the Protection of Personal Data Law ("KVKK"), we offer you the option to consent to the processing and transfer of your personal data abroad for purposes such as the execution and development of the Spectroscopy Project, conducting educational and instructional activities, ensuring the safety, health, and well-being of project staff and students, resolving current and potential issues between participants and the University, maintaining the quality and continuity of services provided under existing or future contracts, developing, organizing, planning, and modifying University services, managing corporate communication processes, events, and social activities, conducting promotional, sponsorship, advertising, and social responsibility projects, creating promotional materials (e.g., photos, videos, interviews), publishing these materials on the University's official website and social media accounts, informing the public and relevant stakeholders (employees, shareholders, business partners, etc.), identifying project participants, conducting analysis and planning for future projects, strengthening the University's brand value, promotion, and reputation, and conducting necessary verification and communication regarding the project. As the Data Controller, we inform you that your personal data will only be processed lawfully and for the purposes stated above. Data may be transferred abroad solely to facilitate the activities specified in this document, as some of our third-party service providers operate internationally.

- Identity Information: Turkish ID number, full name, place/date of birth, passport number, signature, marital status.
- Personal Information: Gender, nationality, educational background.
- Contact and Address Information: Phone numbers, email addresses, emergency contacts, home/work addresses.
- Professional Information: Job title, experience, employer.
- Financial and Tax Information: Salary details, bank account information, tax number.
- Communication Records: Emails, SMS, multimedia messages, information forms.
- Audio-Visual Data: Photos, videos, voice recordings, statements made during interviews.

Pursuant to Article 9, Paragraph 1 of Law No. 6698, the transfer of your personal data abroad will only occur based on your explicit consent. No data will be transferred abroad without your consent. We remind you to review the Privacy Notice and Explicit Consent Declaration before making your decision. Your choice will not negatively impact on your relationship with us. If any changes occur regarding the details outlined in this consent form, we will seek your renewed consent before continuing international data transfers. If you do not provide consent, your personal data will not be transferred abroad.

You have the right to withdraw your consent for processing and transferring your personal data abroad at any time without providing a reason. If you wish to revoke your consent, you must submit a signed request to Istanbul Kültür University. Upon receiving your request, the University will cease processing your data for these purposes. However, withdrawing consent will not affect the lawfulness of any processing conducted based on your prior consent. The University will retain any information required by applicable laws and regulations.

By signing this document, you acknowledge that you have read and understood the information provided above and consent to the transfer of your personal data and that of any student under your guardianship in accordance with the terms and measures outlined in the Privacy Notice.
